**Optional Charge: Please read carefully.**

I agree to pay \$2.00 per hour for my child from his/her 3<sup>rd</sup> birthday for the 20 ECE hours that he/she is enrolled at Tree Town.

1. This hourly charge will be used to continue to provide a higher proportion of ECE qualified and registered teachers than is funded by the Ministry, excursions, sunscreen lotion, spare clothing items, morning and afternoon tea.
2. This will be reviewed annually with our fee's policy.
3. The Centre will give two months' notice if any change is to be made to this agreed charge. I will give two months' notice if any change is to be made to this agreed charge.
4. I understand that this charge is not compulsory and if I choose not to pay there will be no penalty.
- 4a. If Tree Town ECC does not have agreement from all of the parents to pay the optional charge, Tree Town will be forced to withdraw from the 20 hours ECE scheme, as it would be unaffordable to run the Centre.

**Excursions**

Spontaneous excursions will include local parks, libraries, fire stations and neighbouring schools within a comfortable walking distance from the centre. A first aid kit, cell phone and all other necessary supplies are taken on all excursions. Appropriate ratios will be maintained with the children's age and abilities in mind and will not exceed government regulation ratios of 1 teacher to 4 children. If buggies are used we will follow the "Buggy Safety Policy".

**Holiday Policy**

With one weeks' notice your child is entitled to 4 weeks pro-rata holidays per year at 50% of the normal fee. The centre is closed on all statutory holidays. Public holidays will be 50% of the normal fee.

**Child's Illness**

After six months enrolment you will receive four (4) free half-days per year. Please notify the Centre as soon as possible.

**WINZ subsidies**

Full payment of fees must be made until notice of subsidy is received in writing by Tree Town Early Childhood Centre or Tree Town Preschool from WINZ. The subsidy will then be credited to your account.

**Withdrawing your child from the Centre**

Two weeks' notice is required or, payment of two weeks normal attendance fees will be charged.

**Fees**

I agree to pay the current fees for my child as in the Fee Policy.

Fees are due by the due date given on the Invoice. Any unpaid fees after that date will incur a 10% late payment fee. If fees remain unpaid after six weeks, your child will be removed from the Centre roll unless a written arrangement to pay the fees has been reached with management. *If fees remain unpaid, the debt will be put in the debt collectors hands and will incur an administration charge of \$25 + 1.5% interest per week*

If your child is absent for longer than 21 days their enrolment is automatically ceased unless a prior agreement has been reached with Management.
