**Privacy Statement:**

We are collecting personal information on this enrolment form for the purposes of providing early childhood education for your child. We will use and disclose your child's information only in accordance with the Privacy Act 2020. Under that Act you have the right to access and request correction of any personal information we hold about you or your child. Details about your child's identity will be shared with the Ministry of Education so that it can allocate a national student number for your child. This unique identifier will be used for research, statistics, funding, and the measurement of educational outcomes. **Statutory Holidays/ Holiday Policy**

With one weeks' notice your child is entitled to 3 weeks pro-rata holidays per year at 50% of the normal fee. The centre is closed on all statutory holidays. Public holidays will be charged at full fee.

**Child's Illness**

After two months enrolment you will receive five free full days per year. Please notify the Centre as soon as possible.

**Withdrawing your child from the Centre**

Two weeks' notice is required or, payment of two weeks normal attendance fees will be charged.

**Fees**

I agree to pay the current fees for my child as in the Fee Policy.

Fees are due by the due date given on the Invoice. Any unpaid fees after that date will incur a 10% late payment fee. If fees remain unpaid after six weeks, your child will be removed from the Centre roll unless a written arrangement to pay the fees has been reached with management. *If fees remain unpaid, the debt will be put in the debt collectors' hands and will incur an administration charge of \$25 + 1.5% interest per week* Signed \_\_\_\_\_

**WINZ subsidies**

Full payment of fees must be made until notice of subsidy is received in writing from Winz. The subsidy will then be credited to your account.

**Optional Charge: Our centre offers subsidised costs for 20 hours of childcare, for all children 3 years and older.**

*Please read carefully.*

1. I agree to pay \$3.00 per hour for my child from his/her 3rd birthday for the 20 ECE hours that he/she is enrolled at Tree Town.
2. This hourly charge will be used to continue to provide a higher proportion of ECE qualified and registered teachers than is funded by the Ministry, excursions, sunscreen lotion, StoryPark, morning and afternoon tea.
3. The Centre will give one months' notice if any change is to be made to this agreed charge. I will give one months' notice if any change is to be made to this agreed charge.
4. The agreement to pay the optional charge will last for the length of time your child is enrolled at our centre.
5. I understand that this charge is not compulsory and if I choose not to pay there will be no penalty.
6. If Tree Town ECC does not have agreement from all of the parents to pay the optional charge, Tree Town will be forced to withdraw from the 20 hours ECE scheme, as it would be unaffordable to run the Centre.
